Rebuilding Together Houston brings volunteers and communities together to improve the homes and lives of low-income homeowners in need.

Contractor Programs: Critical Systems Repair (CSR) & Roof Restoration (RR). In 2016, contractors completed 219 CSR program which consist of electrical, plumbing, foundation, kitchen & bathroom repairs critical to home habitability. Contractors also completed 213 roof repairs or full replacements (RR).

4b (Code:) (Expenses \$ 570,789. including grants of \$) (Revenue \$)

Volunteer Home Repair Program (VHRP): The VHRP facilitated completion by volunteers of exterior home repairs of 249 houses in 2016. On average, each house repair project utilized a 20-member crew, which worked two Saturdays. RT-H determines the eligibility of the homeowner, specifies the repairs to be completed by the sponsored volunteer crew and supplies the materials to complete the projects and the volunteer sponsor organization supplies the labor and tools to repair the home exteriors. Total value of donated labor was \$2,285,745.

Safe & Sound Services in Program (SSSP): Utilizes teams of 2 volunteers to provide home interior modifications that address fire prevention, fire safety (including how to exit the home in case of fire); modifications to prevent falling, particularly in and around the bathroom (grab bars, raised toilets, non-skid strips in tubs); and room air quality (through installation of air filtration units). This program completed 43 in-home projects with a donated volunteer labor value of \$10,320 in 2016.
